## How to Order a *Tango*

A \$10,000 deposit to be held in neutral escrow is required to reserve a *T600* kit.

Your deposit will be kept in a neutral escrow at Adept Escrow, located at:  
107 E. Magnesium Rd., Spokane, WA 99208-5968.

The funds are in customers' names and *can be withdrawn at any time without penalty and without requiring Commuter Cars' consent.* You would only lose your place on the waiting list.

The kit is mostly-assembled and requires less than 8 hours to complete.

There are 3 major components to the kit:

- The main body of the kit is supplied by Commuter Cars and includes everything except the lower chassis/battery box/batteries, and the drivetrain.
- Lower chassis and battery box, with choice of batteries depending on required range, power, and longevity.
- Drivetrain, which includes motor(s), gearbox(s), brakes, and rear suspension.

**All of the components to complete a basic *T600* can be purchased for \$121,000.** There are several different battery options as well as possible drivetrain options that can affect the price.

Commuter Cars Corporation ("COMMUTER CARS") acknowledges receipt from the person whose name appears at the bottom of this form ("CUSTOMER") of ten thousand dollars (\$10,000.00) as a deposit toward the purchase of a *Tango T600* kit.

1. The estimated selling price of the *Tango T600* kit is one-hundred-eight thousand dollars (\$108,000.00). CUSTOMER understands that the actual selling price may be more or less than this estimate. Price does not include tax or delivery.
2. The deposit is fully refundable and held in an escrow account administered by a 3rd party escrow company: Adept Escrow Service, Inc. ("ADEPT"). COMMUTER CARS has no access to funds. In the event that CUSTOMER wishes to have the deposit refunded, CUSTOMER shall notify ADEPT and/or COMMUTER CARS in writing at the addresses set forth herein. ADEPT shall refund the deposit, without interest, to CUSTOMER at the address set forth below within seven days of receipt of written notice.
3. COMMUTER CARS will notify CUSTOMER at the address set forth below when the CUSTOMER's vehicle is available for purchase in accordance with the reservation number. The reservation number will be assigned by COMMUTER CARS on a first come, first served basis. If CUSTOMER changes its address, written notification shall be made to COMMUTER CARS and ADEPT at the addresses set forth herein.
4. This document does not constitute an offer to sell the *Tango T600*. Accordingly, COMMUTER CARS may cancel this reservation at any time upon written notice to CUSTOMER, together with refund of CUSTOMER's deposit.
5. All currency is in U.S. dollars. Any checks returned unpaid will be assessed a \$25.00 fee to be paid by CUSTOMER.
6. ADEPT is not responsible to notify either party for any reason other than those already specified.
7. ADEPT has no affiliation with COMMUTER CARS and correspondingly makes no judgment on its ability to perform or fulfill its contractual obligations.
8. Deposit shall be held at ADEPT in a non-interest-bearing trust account.
